### Entry Rules:

**Swimmers may enter up to five (5) individual events.**

The eligibility of a swimmer will be determined by his or her age on **November 12, 2006**.

Rules from the current USA Swimming Technical Rules will be in effect.

Entries must be submitted on floppy diskette or CD using the Hy-Tek Meet Manager or Team Manager Software. Adirondack Swimming does not accept NT (no time) Entries and these entries will not be imported to the meet. Team entries must be received by **November 1, 2006**. Entries received after this deadline will be accepted only at the discretion of the meet directors. Entries per session will be limited by the 4-hour session rule. In case the meet is oversubscribed, the meet directors reserve the right to limit the number of entries based on the postmark of the entry and/or entry times. In the event that swimmers are cut from events due to oversubscription of the meet, teams will be notified by November 7, 2006 and entry fees will be refunded.

### USA Swimming Registration:

All swimmers must be currently registered with USA Swimming, Inc. Registrations may be obtained from your club registrar. ALL Adirondack Swimmers MUST be Registered with the AD Registrar by the Meet Entry Deadline. All Adirondack Meets are reconciled for current USA Swimming Registration. Unregistered swimmers will be removed from the meet and a \$25.00 Fine Imposed ([Click Here for More Information](#)).

### Swimming Events:

The entire meet will be pre-seeded with the exception of the 500 free (see below). All events will be swum as timed finals. There will be no event seed cards. All age groups need to obtain their heat and lane assignments from the heat sheets posted throughout the pool area. The 500 free will be deck seeded. Swimmers will be asked to check in before seeding. The event will be swum fastest to slowest alternating girls and boys heats. Heats may be combined to make a mixed gender heat if the meet director and meet referee feel it is necessary.

**Warm-Ups:**

Because of the large number of injuries occurring across the country during warm-ups, USA Swimming allows no diving into the pool during the warm-up period except in the designated sprint lanes. We ask that you inform your swimmers of this rule and ask them to fully cooperate with the club officials and marshals in charge of the area.

**Deck Entries:**

Adirondack Swimming has agreed to allow Deck Entries at AD Meets under the following conditions;

1. Deck Entries are NOT Allowed during Championship Meets
2. Athlete must be USA-S Registered and show USA-S ID Card (those already in meet have been confirmed as registered).

**If athlete cannot prove USA-S Registration, Adirondack accepts Deck Registration, in meets allowing Deck Entries, to UN-AD (unattached, Adirondack) ONLY at a fee of \$100.**

**DECK REGISTRATIONS WILL NOT BE MADE WITH ANY TEAM ASSOCIATION, PLEASE DO NOT ASK.**

3. Coach makes the request for the entry.

4. All Deck Entries will be allowed at the discretion of a combined decision of the Meet Director and the Meet Referee.

**Timers:**

Clubs will be required to provide timers based upon their number of entries. Swimmers have to provide their own timers for the 500's.

**Meet Policy:**

Any swimmer found in an unauthorized area will be asked to immediately leave the premises. No exceptions. Each team is responsible for supervising its members. Due to the size and nature of the facility in which the meet is held, it is particularly important that coaches and parents closely monitor the conduct of swimmers at all times. Swimmers should bring books, playing cards, games, etc. for quiet amusement in the bullpen area. **No one will be allowed on the deck except USA-S Registered Officials, USA-S Registered Coaches, USA-S Registered Swimmers and Timers on Shift.**

**Services:**

There will be a large selection of food items available for all sessions.

**Disabled Athletes:**

Adirondack Swimming welcomes athletes with disabilities. Athletes with disabilities are required to contact the Meet Director at least 2 weeks in advance of the meet so that provisions can be made for any special accommodations.

**Entry Fees:**

An entry summary sheet is also included to compute your team entry fees. The entry fees are \$3.25 per individual event (these include the \$.40 travel fund surcharge), and \$6.00 per relay (including the \$1.00 travel fund surcharge). There is also a \$1 per swimmer surcharge.

For individual events medals will be awarded for 1st – 3rd place, ribbons for 4th - 8th place. For relays, ribbons will be awarded to the 1st - 3rd place teams. Heat ribbons will be awarded for individual events.

There will be an official's meeting conducted promptly 45 minutes before each session. Attendance is MANDATORY to work the meet. Please sign up in official's room before the start of officials meeting.
