#### **Entry rules:**

The eligibility of a swimmer will be determined by his or her age on November 7, 2010.

Rules from the current USA Swimming Technical Rules will be in effect.

Swimmers may enter FOUR individual events plus ONE relay.

This is a DEVELOPMENTAL meet: Swimmers entering this meet must be slower than the listedcutoff times for each event.

No Time (NT) Entries will Not be accepted for this meet.

Entries must be submitted on floppy diskette or CD using the Hy-Tek Meet Manager or Team Manager software.

TEAM ENTRIES MUST BE RECEIVED BY WEDNESDAY., OCTOBER 27.

No phone entries will be accepted.

In the event the meet is oversubscribed, the meet director and meet referee will work together to determine a solution in the best interest of the swimmers.

#### **USA Swimming registration:**

All swimmers must be currently registered with USA Swimming, Inc. Registrations may be obtained from your club registrar. ALL Swimmers MUST be Registered, for the date(s) encompassing the meet, with the AD Registrar by the Meet Entry Deadline. All Adirondack Meets are reconciled for current USA Swimming Registration.

Unregistered swimmers will be removed from the meet and a \$25.00 Fine Imposed. (Click Here for More Information)

NOTE: ALL ATHLETES ATTENDING ANY SANCTIONED MEET, MUST BE UNDER THE DIRECT SUPERVISION OF A CURRENTLY RESGISTERED AND CERTIFIED, USA SWIMMING COACH. IF YOU ARE AN UNATTACHED ATHLETE, OR YOUR COACH WILL NOT BE ATTENDING THE MEET, YOU AND/OR YOUR COACH, MUST CONTACT THE MEET DIRECTOROR AN ATTENDING COACH, IN ADVANCE, TO MAKE ARRANGEMENTS FOR AN ATTENDING COACH TO ASSUME RESPONSIBILITY FOR YOU.

This is a USA Swimming Rule, there are no exceptions.

Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

#### **Swimming events:**

Swimmers may swim 4 individual events and one relay.

This is a DEVELOPMENTAL meet: Swimmers entering this meet must be slower than the listedcutoff times for each event. Any age may enter Open events.

#### Scratches:

The meet will NOT have a positive check-in. Swimmers not reporting to their block at the time of their event will be scratched from that event. Please familiarize your swimmers with the scratch rule.

#### Warm-ups:

Because of the large number of injuries occurring across the country during warm-ups, USA Swimming allows no diving into the pool during the warm-up period except in the designated sprint lanes. We ask that you inform your swimmers of this rule and ask them to fully cooperate with the club officials and marshals in charge of the area. Complete Warm-up Schedule Posted above. See "Time".

#### **Deck entries:**

Adirondack Swimming has agreed to allow deck entries at AD meets under the following conditions:

- 1. Deck entries are not allowed during Championship meets.
- 2. Athletes must be USA-S registered and show a USA-S id card (those already in meet have been confirmed) If a swimmer can not prove USA-S registration, Adirondack will accept deck registration in meets allowing deck entries, to UN-AD (unattached, Adirondack) only, at a fee of \$100.00. Deck registrations will not be made with any team association.
- 3. A coach must make the request for the entry.
- 4. Deck entries will be allowed at the discretion of a combined decision of the Meet Director & Meet Referee.
- 5. Deck entries are subject to a \$1.00 surcharge, per entry, which applies to all entries, individual or relays.

#### Timers:

Clubs will be required to provide timers based upon their number of entries. We will assign lanes and will post a timing schedule on the AD website.

#### Meet policy:

Any swimmer found in an unauthorized area will be asked to immediately leave the premises. No exceptions. Each team is responsible for supervising its members. No one will be allowed on the deck except USA-S Registered Officials, USA-S Registered Coaches with Current Certifications, USA-S Registered Swimmers and Meet Marshalls and Timers on Shift. All Officials and Coaches are Required to display USA Swimming Credentials (USA Swimming Membership Card) while on deck.

If, at an AD Sanctioned Meet, an individual is found on deck, acting in any coaching capacity and is determined to be out of compliance with USA Swimming requirements for coaches, that individual will be removed from the deck and the represented club

#### Services:

Programs, t-shirts, and a variety of concession food will be available for sale. Concession in cafeteria. **Team camp-out area in gymnasium across from pool**.

#### Disabled athletes:

will be fined \$250.

Adirondack Swimming welcomes athletes with disabilities. Athletes with disabilities are required to contact the Meet Director at least two weeks in advance of the meet so that provisions can be made for any special accommodations.

#### **Entry fees:**

An entry summary sheet is included to compute your team entry fees.

Entry fees are \$3.50 per individual event (includes \$.50 travel fund surcharge), and \$6.00 per relay (includes \$1.00 travel fund surcharge). In addition, there is a \$1.00 per swimmer surcharge. All Manual (non-electronic) entries are subject to a \$1.00 Surcharge per entry, individual or relay.

#### Awards:

Medals to 1<sup>st</sup> through 6<sup>th</sup> place for individual events; ribbons to 1<sup>st</sup> through 3<sup>rd</sup> place for relays. Heat ribbons will be awarded for all individual events in all age groups.

#### Officials:

There will be an official's meeting conducted thirty minutes before each session. Attendance is <u>mandatory</u> to work the meet. Please sign up in official's room (computer room on deck) before the meeting.
