**Entry Rules:** The eligibility of a swimmer will be determined by his or her age on June 3, 2011. Rules from the current USA Swimming Technical Rules will be in effect. **A swimmer may enter FIVE individual events.** Entries must be submitted using Hy-Tek or Team Unify software and they must be received **on or before 5:00 pm on Thursday, May 24, 2012.** The Albany Starfish Swim Club is not responsible for entry errors submitted by the teams. In case the meet is over subscribed, the Meet Director and Meet Referee reserve the right to limit the number of entries based on any or all of the following: postmark of entry; entry time; number of heats; and whether team is from outside of the Adirondack LSC. Pentathlon participants will be given preference over Non-Pentathlon participants. In the event entries are returned, the respective team's coach / club representative will be notified before May 30, 2012 and entry fees will be refunded. The Albany Starfish Swim Club reserves the right to enter all their swimmers.

**Please review the schedule of events carefully since non-traditional age groupings are in effect (i.e., 7&U, 8-9, 10-11, 12-13, 14-15, and 16&Over).**

**To participate in the Pentathlon, swimmers must enter all 5 events in their age group.**

**Deck Entries:** Adirondack Swimming has agreed to allow Deck Entries at AD Meets under the following conditions:

1. Deck Entries are NOT allowed during Championship Meets;
2. Athlete must be USA-S Registered and show USA-S ID Card (unless already in meet and confirmed as registered).

**If athlete cannot prove USA-S Registration, Adirondack accepts Deck Registration, in meets allowing Deck Entries, to UN-AD (unattached, Adirondack) ONLY at a fee of \$100.**

**DECK REGISTRATIONS WILL NOT BE MADE WITH ANY TEAM ASSOCIATION, PLEASE DO NOT ASK;**

3. Coach makes request for the entry.
4. All Deck Entries will be allowed at the discretion of a combined decision of the Meet Director and Meet Referee.
5. **ALL Deck Entries will be subject to a \$1.00 Surcharge per entry**

**USA-S Registrations:** All swimmers must be currently registered with USA Swimming, Inc.

Registrations may be obtained from your club registrar.

ALL Adirondack Swimmers MUST be registered with the AD Registrar by the Meet Entry Deadline.

All Adirondack Meets are reconciled for current USA Swimming Registration.

Unregistered swimmers will be removed from the meet and a \$25.00 Fine Imposed. [\(Click Here for More Information\)](#)

NOTE: ALL ATHLETES ATTENDING ANY SANCTIONED MEET, MUST BE UNDER THE DIRECT SUPERVISION OF A CURRENTLY REGISTERED AND CERTIFIED, USA SWIMMING COACH MEMBER. IF YOU ARE AN UNATTACHED ATHLETE, OR YOUR COACH WILL NOT BE ATTENDING THE MEET, YOU AND/OR YOUR COACH, MUST CONTACT THE MEET DIRECTOR OR AN ATTENDING COACH, IN ADVANCE, TO MAKE ARRANGEMENTS FOR AN ATTENDING COACH TO ASSUME RESPONSIBILITY FOR YOU.

**This is a USA Swimming Rule, there are no exceptions.**

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

**Events:** All events will be pre-seeded and swum as timed finals. All age groups need to obtain their heat and lane assignments from the heat sheets posted behind the starting blocks in the pool area. **All 25M events will be swum from the bulkhead into the touchpads. Please be sure that your swimmers in the 25M 7 & under events are in the bullpen prior to their event so that they can be walked out onto the bulkhead by our bullpen parents. The bullpen will be set up in the long hallway outside of the pool entrance doors in the Lobby.**

**Entries:** Entries must be submitted via e-mail to Rosemary Lanzi at email: [albanystarfish3@hotmail.com](mailto:albanystarfish3@hotmail.com) using Hy-Tek or Team Unify software. **All entries must be received on or before 5:00 PM Thursday, May 24, 2012.** Please check all entries carefully prior to submission. **Times may be submitted in Yards, SCM or LCM; converted times may be used. When building the entry file in Team Manager, please be sure to include the proper suffix to identify which type of time you are submitting – “Y” for yards, “S” for SCM, and “L” for LCM. We will convert all times to SCM for event seeding.**

**Entry Fees:** Entry fees are \$3.50 for each individual event (which includes the AD \$0.50 travel fund surcharge) There is a \$1.00 per swimmer surcharge for all participants. All Manual or Deck Entries are subject to a \$1.00 Surcharge per entry.

**Seating:** In an effort to provide adequate viewing for spectators who would like to watch their swimmer's event, but otherwise remain outside the pool area, we have set aside a Temporary Seating Section. This Section will be immediately to your left as you enter the pool area. While other spectator sections are available for more permanent seating, we encourage all spectators to avoid a "camping" mentality and leave the pool area during periods when your child is not swimming.

**Awards:** Ribbons will be awarded for first through eighth place for individual events. Heat ribbons will also be awarded for individual winners in their heat for age groups 7&U, 8-9 and 10-11. **Pentathlon High Point Trophies** will be given out for first through third place following each session.

**Scoring:** Cumulative times will be used for high point award using the Hy-Tek Meet Manager Pentathlon scoring format. An individual must complete all five events in a legal manner to be eligible for the High Point Awards. High Point awards will be based on lowest cumulative times in each division.

**Timers:** Clubs will be required to provide timers for the meet based on their number of entries. Lane assignments will be posted to the Adirondack Meet Schedule on or before May 30, 2012 [www.adirondackswimming.org](http://www.adirondackswimming.org) and will be posted in the program and pool area.

**Meet Policy:**

**Use of Audio or Visual Recording Devices, Including a Cell Phone, is not permitted in changing areas, rest rooms or locker rooms.**

Any swimmer found in an unauthorized area will be asked to immediately leave the premises. No exceptions. Each team is responsible for supervising its members. Swimmers, parents and coaches are expected to dispose of all trash in proper receptacles, clean their respective areas of any debris prior to their departure and observe all posted rules and regulation while on the grounds. **No one will be allowed on the deck except USA-S Registered Officials, USA-S Registered Coaches with Current Certifications, USA-S Registered Swimmers and Meet Marshalls and Timers on Shift. All Officials and Coaches are required to display USA Swimming Credentials (USA Swimming Membership Card) while on deck.**

**If, at any AD Sanctioned Meet, an individual is found on deck, acting in any coaching capacity and is determined to be out of compliance with USA Swimming requirements for coaches, that individual will be removed from the deck and the represented club will be fined \$250.**

***No parents, except those workers indicated in the "Meet Policy" are allowed on deck.***

**Warm-up Procedures:** Because of the large number of injuries occurring across the country during warm-ups, USA Swimming allows no diving into the pool during the warm-up period, except in designated sprint lanes. We ask that you inform your swimmers of this rule and ask them to cooperate fully with club officials and marshals in charge of the area. A swimmer that fails to exit the pool immediately after the conclusion of warm-ups will not be allowed to swim at this meet.

**Disabled Athletes:** Adirondack Swimming welcomes athletes with disabilities. Athletes with disabilities are required to contact the Meet Director and Meet Referee at least 2 weeks in advance of the meet so that provisions can be made for any special accommodations.

**Photographers:** Any photographer or videographer, who intends to take pictures at an Adirondack Swimming sanctioned meet, must complete and submit a Photographer Registration Form to the Meet Director before commencing activity. Forms are available on the Adirondack Swimming website as well as from the Meet Director. [Click here for a direct link to the registration form.](#) Swimmer's families, taking photos of their children from the spectator area, are not subject to this policy.

**Food & Concessions:** There will be a wide selection of food available from the Starfish Café in the small cafeteria. If weather permits, the outside grassy area will be used for seating (bring chairs). In addition, The Deep End will be selling swim equipment during the meet in the pool lobby.

**Time Trials:** If time permits, time trials may be held for swimmers trying to qualify for Speedo Championships, Senior Cut Times or faster. Each time trial is \$5.00. Coaches must request a time trial from the Meet Director and Meet Referee and the Meet Director and Meet Referee will determine when the time trial will be conducted. The Meet Director/Meet Referee reserves the right to refuse time trials longer than 200 meters.

**Officials Meeting:** There will be an officials meeting conducted 45 minutes prior to each morning and afternoon session. Attendance is MANDATORY to work the meet. Please sign up in the Official's room before the start of the official's meeting (back room on pool deck).
